

## Elavon Financial Services DAC

### Country-by-Country Disclosure for the year ended 31 December 2018

#### Basis of disclosure

Elavon Financial Services DAC (the “Company”) and its subsidiaries (collectively “the Group”) prepare consolidated financial statements under International Financial Reporting Standards (“IFRS”).

The Company is a credit institution authorised by the Central Bank of Ireland. The Company is required to submit regulatory returns to the Central Bank of Ireland on a Solo and Consolidated basis for the purposes of assessing, inter alia the capital adequacy on both basis.

All subsidiaries are consolidated for both financial statement presentation and country-by-country reporting.

The disclosures contained in this report have been prepared for the Group on a Group prudential consolidated basis as at 31 December 2018. These disclosures have been prepared to comply with Regulation 77 of Statutory Instrument 158 of 2014 “European Union (Capital Requirements) Regulations 2014” (Statutory Instrument 158 of 2014).

3. For the purpose of the disclosure, "Tax Paid/(Received)" is assumed to be represented by cash payments paid to/received from the appropriate tax authorities in the relevant jurisdictions irrespective of the tax year to which the payment relates.
4. For the purpose of the disclosure, "Number of Employees" is presented on a "Full Time Equivalent" basis, rounded to the nearest full number.
5. For the purpose of the disclosure, the "Group Establishments" are assumed to include all branches and subsidiaries of Elavon Financial Services DAC.
